## Requirements of Membership

Persons seeking membership through their organization must attach the following documents to the application form along with a valid picture ID.

- Recent Job Letter or
- Recent Salary Slip

Person seeking membership through family members must submit the following along with a valid picture ID.

**(Through a spouse) :-** Your marriage certificate.

**(Through a parent) :-** Your birth certificate.

**(Through a child) :-** Your child's birth certificate your name must appear on the birth certificate or a statutory declaration.

**(Through a sibling) :-**

Both you and your siblings birth Certificates showing the common link of parent(s). If you and your sibling are related by your father only and his name does not appear on the birth certificate, you will require a Lawyer's letter. If you and your sibling surnames are different on the application to what is on the birth certificate, legal document for change of surname must be provided. e.g. marriage certificate or deed poll.

**(Through an Aunt/Uncle) :-**

Your birth certificate and your parent and their sibling's (who is your aunt or uncle). If the surnames are different on the application to what is on the birth certificate, legal document for change of surname must be provided. e.g. marriage certificate or deed poll.
